COLLECTION SUMMARY

This collection contains primary documents relating to William Wells Wolcott and his father James Wolcott, both of Maumee, Ohio.

PROVENANCE OF THE COLLECTION

This collection was donated by the Lambillotte-Willard Family, who are descendants of both William and James Wolcott.

BIOGRAPHICAL INFORMATION

William Wells Wolcott was born ca. 1821 to Judge James Wolcott and Mary (Amehkoonsahkwa) Wells, but soon after the family moved to Fort Wayne, Indiana (Kiihkayonki). He was the grandson of Myaamia adoptee Captain William (Eepiihkaanita) Wells and his wife Weenankapita and the great-grandson of Myaamia War Leader Mihšihkinaahkwa also known as Little Turtle.

His father, James Wolcott, born in 1790 in Connecticut, was a judge in Fort Wayne, and William and his family lived there until 1826. It was then that they moved to Maumee, Ohio, which is located near present day Toledo. After their relocation, James Wolcott opened and ran a freight business on the Maumee River, with his two ships, the General Harrison and the James Wolcott. Even though Wolcott had left his judgeship and entered the business world, he still offered legal help to his friends and family, especially in matters of land his Myaamia relatives had been given in treaties with the Americans. Along with his business endeavors, James was also very active in local politics. In 1838 he was elected as the President of the first Village Council and in 1843 he became the Mayor of Maumee.

On February 19, 1843 Mary Wells Wolcott died in Maumee. Soon after this William married Eliza Border, an Englishwoman who had immigrated to the Maumee area. William and Eliza had three children: Effie born in 1850, Zoe born in 1851, and Byron born in 1853.

As he got older William entered the family business and worked in the shipping industry with his father. After James Wolcott's death in January 05, 1873, William took over the business. Along with this, he followed his father's footsteps in entering the politically arena, being a member of the Maumee City Council for many years and active in politics from the 1880's into the 20th century along with his brother, James M. Wolcott and his son Byron Wolcott. William died February 1, 1924 in Maumee.

SCOPE AND CONTENTS OF THE COLLECTION

The legal documents encompass both James Wolcott's only papers in the collection and some of William Wolcott's papers. James' documents tend to focus on land acquisition issues and members of his family, including his wife's relatives, granting him power of attorney in their legal and land concerns. However, most of the documents are related to William's legal affairs. These include correspondence between William and a law firm based in Houston, Texas, Brashear & Ashe, involving the case of Molly Trapp, who was a friend of the family that had relocated to Texas. However, the most prominent legal document in the collection is that written by William Wolcott in 1894 to prove his status as a Myaamia person and therefore, entitled to the benefits of his citizenship. Because his family had moved away from any Myaamia community, they had been removed from the rolls several years back. William, however, still had relatives in the community and wished for his family to be placed back on the rolls as Myaamia people. These legal documents extend from 1825 until 1898.

The personal correspondences are either letters written to and from William Wolcott and his wife Eliza Border Wolcott, or letters to and from James or William Wolcott to their Myaamia relatives either living in Fort Wayne (Kiihkayonki) or the Miami Reservation in Kansas (Waapankiakamionki) depending on whether it was before or after the Myaamia forced removal in 1846. These letters vary in years stretching from 1844 until 1888.

Most of the business documents relate to James and later William's commercial shipping business. Wolcott owned freight ships, most notably the General Harrison, and used them to transport people and objects on the Maumee River. Most of these documents are financial in nature; however, within the series there are also several manifests of different voyages, which

give a clear idea of the number of people or cargo that ships like the General Harrison could carry. Along with those, there are several political documents relating to Lucas County and the political influence of the Wolcott Family. William, his brother James, and his son Byron, were all on the Maumee City Council, with James and Byron both being Mayors of Maumee. Overall these documents extend from 1825 until 1916.
