#### **COLLECTION SUMMARY**

This collection features correspondence, diaries, scrapbooks, notebooks, business papers, and photographs from the Covington family that detail life in late 19<sup>th</sup> century Southwestern Ohio. Additionally the collection contains correspondence and other materials from the Riggs and Williams families. The Riggs' were missionaries to the Native Americans in South Dakota, while the Williams' were missionaries in Japan.

#### PROVENANCE OF THE COLLECTION

A large portion of the collection was purchased by Miami University from Mary Hamilton Covington, wife of Samuel Fulton Covington, in 1915. Samuel and Mary's great-great-grandchildren, Roger Lea Williams and Martha Williams King, donated additional materials in 2006 and 2011.

#### **BIOGRAPHICAL INFORMATION**

Samuel Fulton Covington was born in Rising Sun, Indiana, on November 12<sup>th</sup> 1819, to Robert E. Covington and Mary (Polly) Fulton Covington. Both the Fulton and Covington families contributed to the founding of Rising Sun, and Samuel received an excellent education from some of the best teachers in the area.

Samuel attended Miami University from 1837 to 1838, at which point he dropped out to support his widowed mother. Samuel always regretted not completing his education at Miami. For a while he worked as a clerk in a store and on a steamboat. He simultaneously studied law, and was admitted to the bar in 1843. However, practicing law did not appeal to him so he and his brother John B. Covington joined together to work in newspaper publishing and other commercial pursuits in Rising Sun.

Just why Samuel moved to Cincinnati in the 1850's is unclear, but the allure of this large business center so nearby was likely simply too attractive to resist. He had settled on a career in insurance and worked for several different firms, before finally joining the Globe Insurance Company as its secretary in 1865. He had previously been secretary for the Western Insurance Company.

Samuel was fortunate to have a wealthy associate, Thompson Dean, with surplus money to invest and a desire to establish an insurance company in Cincinnati. Dean did not want to run the Globe Insurance Company on a daily basis and needed a trustworthy and energetic partner to keep the office running. A building was purchased at 68 Third Street, near Walnut Street, which was at the heart of the Cincinnati financial district. Insurance companies in Cincinnati were often involved in marine insurance and Covington and his mentor Dean were involved in insuring the booming, but risky, steamboat trade.

Covington was made secretary of the Globe Insurance Company at its establishment in March 1865. Dean had moved to New York City the prior year and so another associate, James H. Pepper, was the president.

In 1867 Covington moved up to vice president and eventually became president of the firm in 1874 when Dean sold his investment to Covington. By 1879, Globe had paid out over \$500,000 in claims and \$159,000 in dividends. The Globe closed soon after Covington's death in 1889.

Samuel married Mary Hamilton on April 2<sup>nd</sup> 1843. Mary's parents were Jonathan Newman Hamilton and Eleanor Davis Hamilton. Samuel and Mary settled in Rising Sun during the early years of their marriage. After moving to Cincinnati during the early years of his career, he and his family initially lived in the East End, convenient to the downtown area. Then they settled in a flat on Third Street just a few minutes from the office. They later relocated to suburban Madisonville.

Samuel and Mary had five children. The eldest, George Bancroft, enlisted in the Union army at the age of seventeen in the 17<sup>th</sup> regiment of Indiana volunteer infantry. After three years of service, during which time he attained the rank of adjutant of his regiment, he fell mortally wounded in one of the minor engagements of the Atlanta campaign on May 25<sup>th</sup> 1864. His last

message to his parents was, "Tell them I died a Christian soldier, trying to do my duty." He is buried in Rising Sun, Indiana.

Another son, John Ichabod, graduated from Miami University with the class of 1870. He was initiated into the Beta Theta Pi fraternity, and remained active in the organization until his death. After leaving college, he became associated with his father in the administration of the Globe Insurance Company. He then accepted the position of manager of the Equitable Accident Insurance Company, and later a like position in the Insurance Department of the American Cotton Oil Company of New York City. For a time he was proprietor and editor of The Business Observer, and throughout his life he was a frequent contributor to newspapers and magazines. He died of a heart attack in 1895, and he left his widow Clara, and two children, Annette and Mary, both of whom are graduates of The Western College for Women. John's widow and daughters moved into Lewis Place, Oxford Ohio. At the time the building was owned by a former roommate of John Covington. Since 1903 Lewis Place has been the residence of Miami University presidents.

The eldest daughter, Harriet, after graduating from the Cincinnati Young Ladies' Seminary, was married to the Rev. James H. Shields, of the Presbyterian Church. She died in 1897, leaving one son, Samuel. In 1913 he was married to Ruth Hickman, by whom was born one son, James Shields.

Samuel and Mary's fourth child, Mary (Mollie), graduated from the Highland Institute in Hillsboro Ohio, and married Joseph Cox of Cincinnati in 1877. She and her infant son died during childbirth on July 26<sup>th</sup> 1880.

The youngest daughter, Florence, likewise graduated from Highland Institute and in 1883 married Harry Hidden and moved to Kansas City, where her husband engaged in business. To them were born three children, Otis, Florence and Harry. The two former died in childhood. The latter was a student at Williams College. After the death of her husband, Mrs. Hidden returned home to live with her mother in Madisonville. Florence died in the family home in 1920.

Samuel Fulton Covington died in 1889, and was buried at Spring Grove Cemetery. He and his son, John, bought lot 86 in section 22, and a large majority of the family is now buried there. Mary Hamilton Covington remained in their home at Madisonville until her death in 1921. She was 96-years-old, and had survived her husband and all of her children.

John's daughter Mary married Stephen Riggs-Williams who was the head of Miami's zoology department. Throughout most of the collections Mary is referred to as Mary C. Williams, so as not to be confused with her grandmother, Mary H. Covington. Stephen Riggs-Williams was a prolific writer in his own right. Many of his correspondence are contained in the collection. Stephen's extended family were missionaries to Japan, and the Native Americans of South Dakota. Many manuscripts related to missionary life are also included in the collection.

#### SCOPE AND CONTENTS OF THE COLLECTION

The collection begins with the correspondence series which includes family letters and letter books. Most of the material is from the mid to late 19<sup>th</sup> century. Early correspondence is mostly between Samuel F. Covington and his sons John I. Covington and George Bancroft Covington. The family communicated on a daily basis, and talked regularly about travel,

business, current events, and family matters. The women of the family also wrote regularly to their family and friends. Much of John I. Covington's time at Miami University is documented in the correspondence, as John wrote nearly every day to his family. Letters also document John I. Covington and Clara (Pumphrey) Covington's early courtship.

Subseries II contains bound letter books, which are copies of letters on thin trace paper which are then organized by date and bound into volumes. Samuel F. Covington used this technique to make copies of outgoing letters, and the collection holds many of these original letter books.

Subseries III of the correspondence series consists of letters from Stephen Riggs Williams. The letters have been transcribed and organized chronologically in separate volumes. The letters date from 1886 through 1954.

Series II includes a wide variety of diaries, notebooks, and journals belonging to members of the Covington family. Samuel F. Covington and John I. Covington both kept very detailed pocket diaries and journals in which they would write short notes, thoughts, and business related memos. Diaries of Mary H. Covington are also included, and she, too, kept a regular diary. Many of her notes revolve around the family, domestic life, and family history.

Series III encompasses material related to Samuel F. Covington's son, George Bancroft Covington. George B. Covington was a Union soldier in the Civil War, and was mortally wounded during battle in 1864. This section of the collection includes original correspondence between George B. Covington and his family during his time in the Union Army. In addition to the correspondence is a collection of papers and miscellaneous materials related to George B. Covington.

Series IV consists of a variety of newspaper scrap books. Many of the scrapbooks were likely compiled by Samuel F. Covington and cover dates from the 1840's into the 20<sup>th</sup> century. Some of the scrapbooks are described by topic and these focus on things such as Cincinnati history, insurance, religion, transportation, poetry, and politics.

The Covington business papers are the subject of Series V, and much of the material is related to the Globe Insurance Company in which Samuel F. Covington was involved for many years. Included in this series are business-related correspondence and letter books which include copies of letters written mostly by Samuel F. Covington. There are also many ledger books and account books that document financial matters related to the insurance business. Subseries III includes miscellaneous business correspondence and papers. Included in this subseries are items such as business pamphlets, insurance-related cards and small advertisements. Invoices, bank account information, checks, and insurance claim papers are also found here. Miscellaneous items related to Cincinnati industry and business are also found here as Samuel F. Covington was involved in local and national civic and political affairs. Covington was involved in the Cincinnati Chamber of Commerce as well as the board of trade. He was heavily involved in issues related to transportation especially on the Ohio River.

Series VI contains all of the Covington family photographs and photo negatives. The photographs span more than 150 years documenting the family from the early 19<sup>th</sup> century up to the beginning of the 21<sup>st</sup> century. The photographs include the early Covington family beginning with Samuel Covington and his wife, Mary H. Covington, as well as several generations of descendants leading into the Riggs-Williams Family. Box 46 includes the earliest

photographs. The earliest photos include tintypes and daguerreotypes. A photo album of the Riggs-Williams family is also located here as well as several glass plate negatives. Box 47 includes photographs primarily of the Covington family as well as photos of the family home in Madisonville and various photos of groups of family members together. Box 48 consists mostly of photos of the Riggs-Williams family primarily in the 20<sup>th</sup> century. Box 49 houses a large portrait of Samuel F. Covington and his immediate family. Lastly, Box 50 houses a large assortment of photo negatives, most of which are later 20<sup>th</sup> century 35mm photo negatives.

Series VII includes a small collection of vinyl records and cassette tapes. An album of vinyl records includes recordings of Mary Covington Williams, and the cassette tapes are recordings of Mark Williams related to family ancestors and descendants.

Series VIII, Miscellaneous Materials, is the last series of this collection and includes six subseries. Subseries I includes an assortment of notes on family history. Subseries II is a collection of miscellaneous school-related materials including school notebooks, notes, and materials related to Miami University. Subseries III contains an assortment of miscellaneous newspaper clippings, both original and photocopied. Subseries IV includes a small collection of materials related to the Riggs-Williams work as missionaries. Subseries V includes miscellaneous materials related to Annette Covington, a grand-daughter of Samuel and Mary Covington, and a notable regional artist. Within this subseries, one can find her notes, notebooks, copies of sketches and photocopies of some of her art. Series VI, titled Uncategorized Miscellaneous Materials, includes a broad range of miscellaneous items that do not fit elsewhere in the collection. This subseries includes items such as advertisements, pamphlets, tickets, programs, invitations, and calling cards.
